- Active and valid Indiana State Board of Massage Therapy license is required. A current St. Joseph County Health Department Massage Therapist permit is required; maintaining the permit will also be required.

- Requires technical knowledge and expertise necessary to provide therapeutic and relaxation massage treatments to recipients.
- Requires strong knowledge of medical terminology, anatomy, and physiology in order to perform and communicate massage assessments and treatments with recipients.
- Requires current CPR/AED certification and First Aid Certification or arrangements to be certified within the first three months of employment.
- Demonstrates the interpersonal and communication skills (both verbal and written) necessary to interact effectively with a diverse group of massage recipients in a professional, courteous, friendly, and sincere manner.
- Ability to work within a team environment.
